Leader Guide

Theme: While the hidden global system of human trafficking can seem too intangible to infiltrate, there are clear, practical, and critical steps everyone can take to be a part of the solution. Once you have been made aware, consider how God can use your knowledge to help prevent, rescue, and heal people who have been abused by this network.

Note to the Leader: The Web sites included in the Additional Resources section at the end of this Hot Topic will provide you with more detailed information on human trafficking you can use as you facilitate this discussion. Included in the sites provided are ways traffickers lure people into what ends up being prostitution, facts about the trafficking industry, as well as tips for being safe and reporting incidences. This additional information will allow you to customize this Hot Topic and be able to discuss the issue of human trafficking on a level that is appropriate for the girls you lead.

Contrary to a common assumption, human trafficking is not just a problem in other countries. Cases of human trafficking have been reported in all fifty states, Washington D.C., and some U.S. territories. Victims of human trafficking can be children or adults, U.S. citizens or foreign nationals, male or female.

According to U.S. government estimates, thousands of men, women, and children are trafficked to the United States for the purposes of sexual and labor exploitation. An unknown number of U.S. citizens and legal residents are trafficked within the country primarily for sexual servitude and, to a lesser extent, forced labor.
